Dear District Council 33 Member,

As you know, we have transitioned our legal services in house, so that we can provide you with quality legal representation in our Philadelphia Courts. We now offer a full complement of legal services for your use including the following:

- Family Law (Child Custody & Support; Divorce; Adoption; Juvenile Justice)
- Civil lawsuits brought against you
- Drafting of Wills, Power of Attorney and Living Wills
- Bankruptcy
- Small Claims matters, such as Credit Card Lawsuits
- Criminal Law (Misdemeanors and summary offenses, Criminal Expungements)
- Driver's License Restoration
- Real Estate (Deed Changes, Real Estate Purchase Closings)
- Legal Consultations in various areas

As we transition back to in-house legal representation, please know that we are working hard every day to ensure that work begins on the legal matters returning to our office in a timely matter so that we can bring your case to its conclusion. We ask that you continue to be patient while we are going through this transition.

Upon receiving notice of your already existing case, we are required by law to enter our appearance with the Clerk of Court to let them know that we represent you. The courts prohibit anyone from reviewing and receiving information about a case that they are not a party to as a Plaintiff or Defendant. Only after an attorney has provided the Clerk of Court with proof that one of the parties has retained the person as their Attorney of Record, can the attorney start work on the case. Additionally, if there is a previous attorney of record, that person must withdraw his or her appearance from the case before the new attorney can begin working on the case.

We understand your anxiety regarding divorce cases, in particular. Please know that we have been filing our Entry of Appearance in all the divorce cases that we receive in this transition back to in house representation. Unfortunately, as an after effect of the worldwide COVID 19 pandemic, there is a backlog in our Family Court of processing attorney Entry of Appearances in divorce cases. The Family Court has assured us that they are working to ease the effects of the backlog and have advised us to provide multiple entries of appearances for the same case and we have

We have also obtained the services of a paralegal who will work exclusively on the divorce cases of DC33 members so that once the entry of appearances are processed, we are able to immediately proceed. In the meantime, we are working to have the assigned attorney meet with you in person, via ZOOM, or by telephone to discuss your case.
